- the variety of RICS learning and development programmes, now being offered to the Indian property and construction professionals

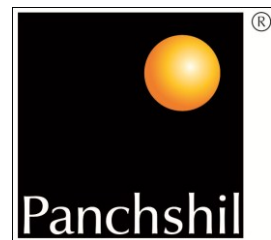
